There being a quorum present, the meeting was called to order at 4:05 p.m.

Horace Coleman, Jr., Chairperson presiding:

Mr. Coleman opened the floor for nominations for candidates to serve as a Trustee elected by the active members of the Retirement System. Nominations were taken from the floor.

Ms. Stovall, an active board member, nominated Mr. Andrew Murphy, an active member and resident taxpayer of the Kansas City, MO School District as a Trustee active member.

Mr. Von Smalley, an active member and resident taxpayer of the Kansas City, MO School District, nominated himself as a Trustee active member.

Mr. Smalley, an active member, nominated Mr. Anthony Madry, an active member and resident taxpayer of the Kansas City, MO School District as a Trustee active member.

Ms. Stovall, an active board member, nominated Mr. Javier Alfonso, an active member and resident taxpayer of the Kansas City, MO School District as a Trustee active member.

There being no other nominations, the Board unanimously agreed to close the nominations for active member Trustees.

Mr. Coleman asked for the new trustees, Anthony Madry and Von Smalley to introduce themselves to the Board.

After introductions, Representative Richard Brown said a few words about the 75th Anniversary Celebration and his continued interest and intent on staying up-to-date on issues facing Missouri State pension systems. Representative Brown is a member of the House Pensions Committee and the Joint Committee of Public Employee Retirement.

Mr. Coleman called for the IT security assessment presentation. Mr. Smith and Mr. Schaefer presented an overview of the work performed. The Board requested the Business and Technology Committee review the IT assessment report and recommendations and develop an implementation plan for the Board's review.

Ms. Gierer provided her report on operational, communication, and Board issues. Ms. Gierer informed the Board on the Wednesday, October 2nd swearing in performed by Honorable Judge Midkiff for the new Trustees, Von Smalley and Anthony Madry, who will both serve through December 31, 2019.
