# YOU CAN VOTE FOR A CANDIDATE FOR THE KCPSRS BOARD

#### **Election Process:**

All eligible nominees will be on the KCPSRS election ballot.

- Ballots will be mailed to your home address in November and an online ballot will also be emailed to members and retirees for whom we have an email address.
- Ballots will include voting instructions and nominee bios for review.
- If voting by mail, complete the ballot and place it in the enclosed return envelope.
- If voting online, login to the website using your unique member number and election passcode to cast your vote. **Do not mail your ballot if** you plan to vote online.

• Only one vote per candidate will be counted. The election results will be announced on the KCPSRS website and published in the Winter's Edition newsletter.

#### **Summary of Board of Trustees Responsibilities** The Board is responsible for:

- Ensuring the Retirement System is appropriately governed and managed with the overriding goal of protecting Fund assets.
- Creating and maintaining an atmosphere that encourages frank and collegial discussions both at the Board and Committee level and between the Board and management.
- Establishing and communicating Board policies and priorities and monitoring performance considering its established policies and priorities. Each Board Member must:
- Act as a fiduciary of the Retirement System. A fiduciary is a person who holds the trust and confidence of another and is charged with acting in the best interest of this individual or group.
- Attend regular meetings of the Board of Trustees normally held at 4:00 – 6:00 p.m. the first Monday of each month, except no regular Board meetings in July or August.
- Attend special meetings of the Board, which may be held occasionally as needed.
- Complete at least six hours of Board education each year. A new Board member must complete six hours of Board orientation education within ninety days of becoming a Board member. Educational opportunities are available on-line and in person.

November 21, 2023 Ballots must be received by the election service by 5 p.m.

December 4, 2023 Election results reported to the Board of Trustees

Log into your <u>My Account</u> on the website <u>www.kcpsrs.org</u>. Haven't registered for <u>My Account</u> yet? It's easy! Watch the short instructional <u>video</u> available on our website under the <u>Publications</u> tab. Your member statement contains your contributions plus interest account balance, your service credit, (number of years with the Retirement System), your beneficiary information, and your retirement plan (plan B or C). Your statement is available for viewing and printing via <u>My Account</u> anytime day or night, when you are ready! If you are brand new to the Retirement System, it will take two to three months after your first pay period for your account information to be established and uploaded to the system. Note that some KCPSRS members also have investments outside KCPSRS in a separate retirement plan(s), e.g., defined contribution plan such as a 403 (b) or 457 Plan. If that sounds like your situation, then we encourage you to work with a financial planner to help you make informed decisions.

### **RECENT DATA BREACH**

Recently, there has been news coverage of a major data breach that occurred in late May 2023. This affected the federal government, state governments, universities, health care organizations, corporations and pension systems in the United States due to a cyberattack to MOVEit, a managed file transfer software tool used by these organizations to transfer data files.

KCPSRS does utilize PBI Research Services as a vendor to research contact information for members that are unreachable. **PBI has determined that KCPSRS members were not affected by this breach.** If you received a letter from PBI regarding the data breach, it is due to your association with another organization which may include your financial advisor or health care organization. # **TEACHER SALARY STATISTICS**

Teacher salaries have always been a hot discussion topic among educators. Even retired teachers feel it is important to discuss current teacher salaries compared to years past. According to the National Education Association (NEA), "when adjusted for inflation, the average salary of teachers has actually declined by an estimated 6.4 percent, or \$3,644, over the past decade." Of all fifty states, Missouri lies in dead last place when it comes to the starting salary of an average teacher, which in 2021-2022 was \$34,052. Missouri also placed 47th out of the 50 states on the national teacher salary ranking, with an average salary of \$52,481, for the same year.

What can you do to assist your colleagues in the fight for better teacher salaries?

The NEA suggests that teachers and education staff should follow these tips for a campaign to increase salaries:

- Build broad unity and develop relationships with community allies which can be accomplished by requesing input from everyone involved and connecting with education members in the same region. Form a relationship with members of the school board to garner support for improving salary schedules.
- Devise a long-term campaign plan by analyzing your colleague's assets and leadership roles to show the importance of good neighbors and community leaders.
- Gather solid, reliable data and create strong arguments for increasing professional pay for education staff. The NEA website, <u>www.nea.org</u>, has statistics on salaries, cost of living, and education pay in nearby states.
- Develop a communications plan that includes social and digital media. Create local stories and visuals to demonstrate how teachers often use their own funds for classroom supplies or the use of older textbooks or damaged classroom furniture.
- Lastly, follow the money. Keep an eye out for legislation and budget at both the state and local level that can affect school funding.

Remember the "we're worth it" mentality. Teachers and education staff deserve a living wage as they educate the next generation of leaders.

- If you were to pass away prior to retirement, your designated beneficiary would receive your account balance or in specific situations a monthly benefit.
- Upon meeting eligibility criteria, you are eligible for a monthly benefit payment for the rest of your life.
- You can withdraw your contributions plus annual interest if you leave employment.
